AN EXAMPLE OF LABOR TRAFFICKING

- Alice was recruited to sell magazines with a traveling sales crew.
 She was excited about the opportunity to travel and make money.
- However, she soon realized it was all too good to be true. The team was crammed into small vans and forced to share crowded hotel rooms.

 When Alice didn't meet her sales quota, she didn't get paid.
- When Alice voiced concerns to her boss, he threatened to abandon
 her in a dangerous area far from home. Alice was scared and didn't
 know how to leave her situation.
- Luckily, a staff member at one of the hotels the group was staying at noticed that something was off and contacted the **National Human**Trafficking Hotline. Alice was connected to caring local providers and received the support and resources she needed to safely leave her trafficking situation.

LABOR TRAFFICKING

Labor trafficking is a crime that happens in communities throughout the United States, including North Carolina. Be aware of warning signs to help protect guests and keep your community safe.

What is labor trafficking?

Labor trafficking is a form of human trafficking where victims are tricked into work through the use of force, fraud, or coercion.

SEE?

- Groups piling into vans Multiple hotel rooms
- booked under one name
 Large cash payments
- Large cash payment

Disruptive parties A clear pecking order within the group

HEAR?

- Requests for a single room key despite multiple inhabitants
- Talk of hunger/a lack of resources
- Talk of debt or work quotas
- Talk of frequent travel and not
- knowing what city they are in
 Bribes being offered to staff in return for special favors

DO!

- Record what you have observed and collect identifying information like names and license plate numbers
- Report any suspicious activity to your supervisor and follow the established protocols of your workplace

DO NOT:

- Be complicit; it is illegal to assist in the continuation of, or to benefit from, human trafficking situations
- Place yourself in harm's way; report the incident to others who are equipped to handle it

LABOR TRAFFICKING RED FLAGS

- An individual's personal documents are being withheld from them
- An individual's decisions are being made by someone else
- Work is not being paid in full, or payment comes in the form of housing, clothing, or food
- An individual shows fear that something bad will happen to them if they leave their current employment situation
