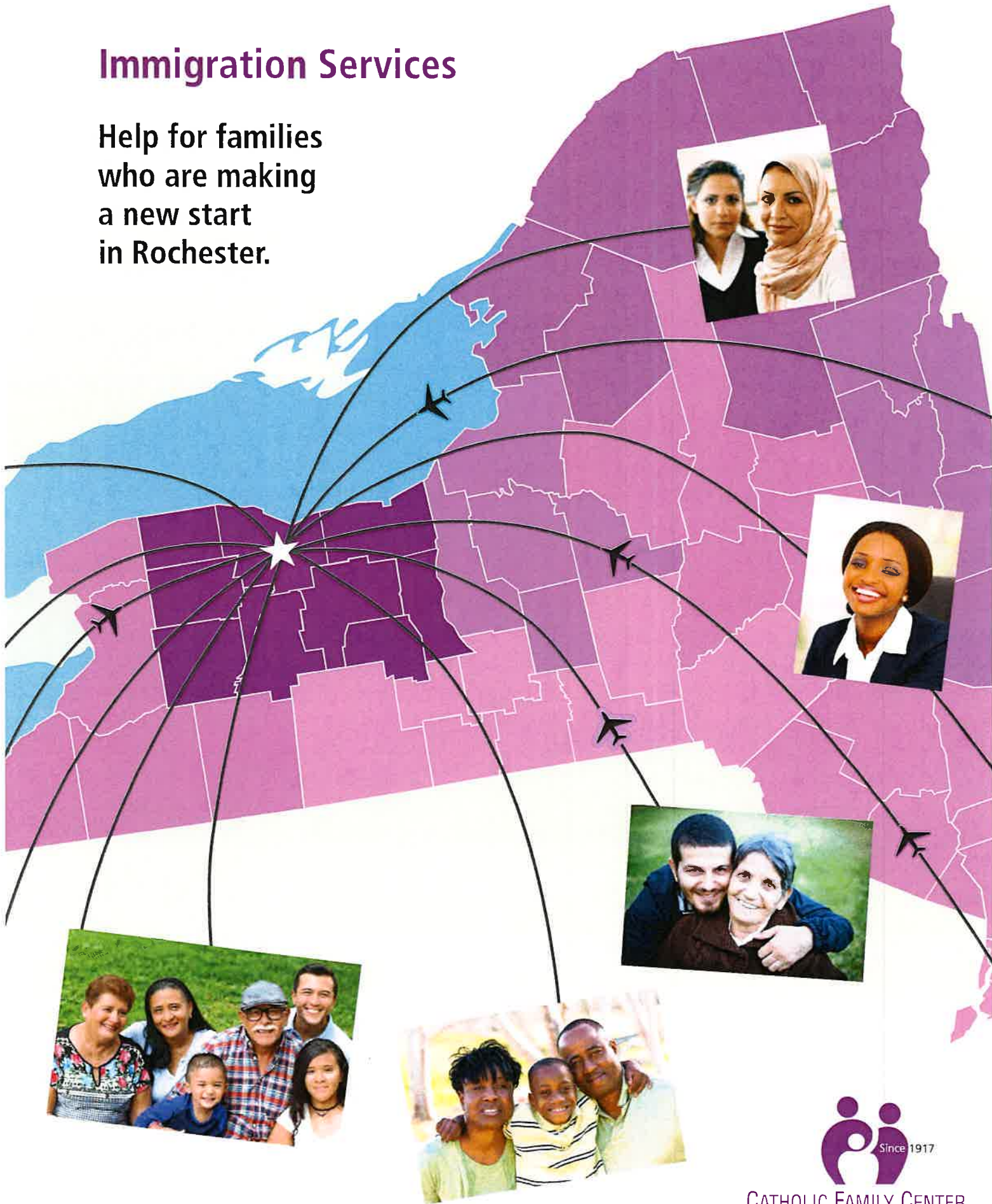

### Citizenship Classes & Citizenship Classes with ESL support - FREE

Citizenship preparation classes cover the English vocabulary on the citizenship test, civics questions, and a welcoming place to practice for the U.S. naturalization interview.

These classes are for any student, regardless of their level of English/ESL, from beginner, intermediate and higher levels of English.

### Green Cards, Renewals & "Adjustment of Status"

Catholic Family Center provides assistance to both refugees and immigrants who wish to apply for their initial green card after living in the U.S. for at least 1 year.

Applications we support include:

- Adjustment of Status -Refugee/Asylee (I-485)
- Adjustment of Status Cuban Parolee (I-485)
- Removal of Conditional Residence/Marriage (I-751)
- Affidavit of Relationship - USCCB cases no charge
- Green Card Renewal/replacement (I-90)

### Naturalization Assistance

Naturalization Assistance helps Legal Permanent Residents (green card holders) complete the application for citizenship.

To be eligible to apply for citizenship, you need to meet certain resident and test criteria, and be able to read, write and speak in English.

We assist with the following applications:

- Naturalization (N-400)
- Certificate of Citizenship (N-600)
- Application for Replacement of Naturalization/ Citizenship (N-565)

### Reuniting Families

Providing assistance to refugees and asylees who wish to petition for eligible family members to come to the U.S.

Any person who has been admitted into the United States as a refugee or asylee in the past 2 years may be able to file an application for I-730 and/or Affidavit of Relationship for the "Follow to Join" application. CFC can help with applications through a variety of ways including:

- Refugee/Asylee Family Petition (I-730)
- Petition for Alien Relative (I-130& 130A)
- K Fiancé or Spouse Visa (I-129F)
- Employment Authorization (I-765)
- Affidavit of Financial Support (I-864/I-134)
- Application for Travel Document (I-131)

### Immigration Legal Counsel

Catholic Family Center offers access to qualified representatives as well as immigration attorneys from Journey's End and Legal Aid Society. Consultations are by appointment only; no walk ins.

### Cuban Haitian Immigration Services

The CHES Program provides a full range of immigration assistance to Cuban and Haitian Entrants, including adjustment of status, employment authorization, and renewal/ replacement of "green cards."

### Other Application Assistance

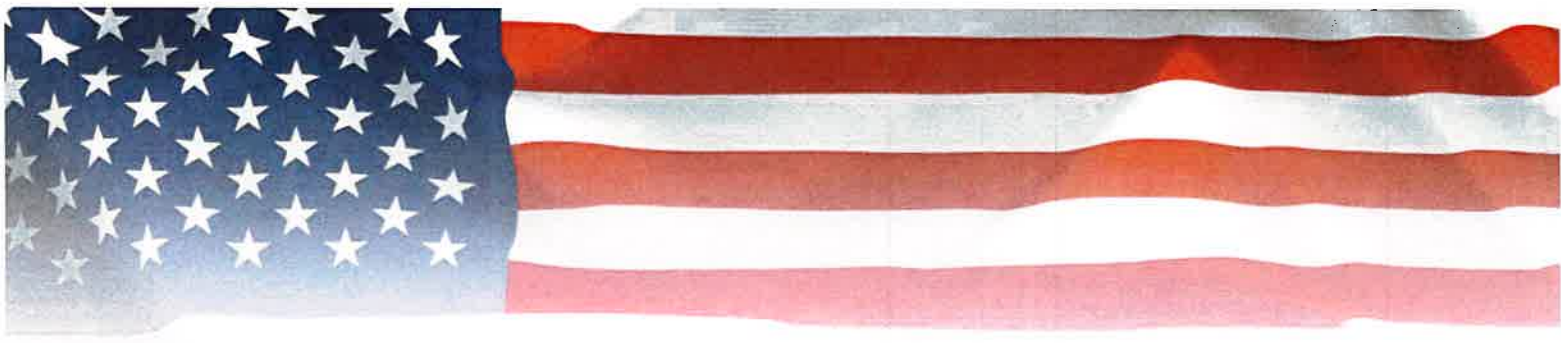

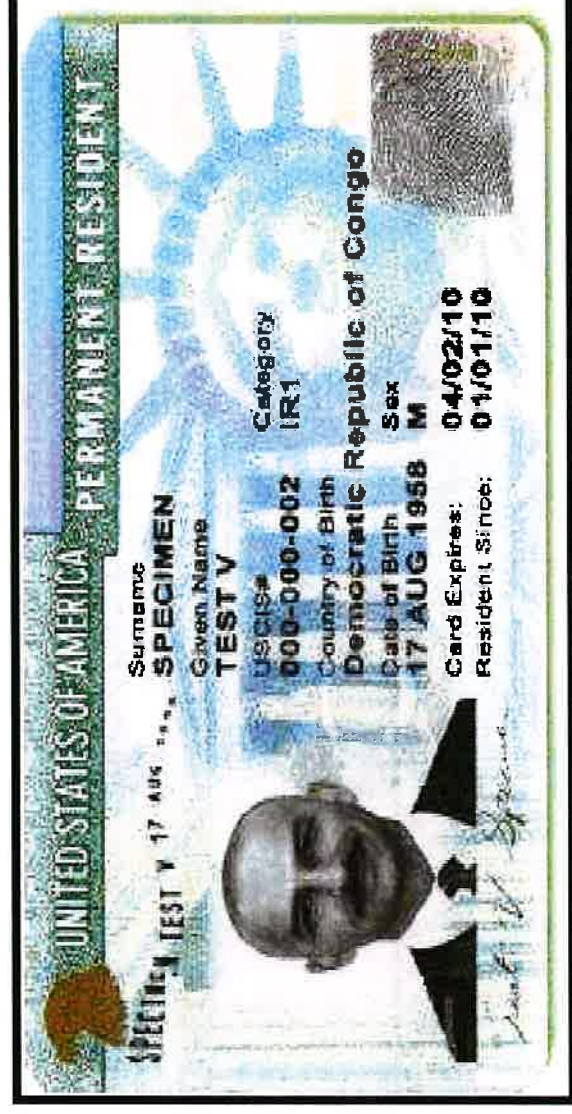
#### About Catholic Family Center

# Important Documents

- ***Green Card (Can apply after living in USA for 1 year)***
- Means you are no longer a refugee
- Permanent Residence VISA, Takes the place of I-94 as official document
- Able to travel outside of U.S. for 6 months
- Must be up to date with all vaccinations in order to complete process
- No criminal record





# **Green Card Information**

- Go to [www.uscis.gov/green-card](http://www.uscis.gov/green-card) for all necessary information, assistance and forms
- Must file form I-485 and form I-693 together (No Fees)
- Schedule appointment with Civil Surgeon to complete a medical examination and form I-693 (See USCIS website for available providers. Fee involved for examination/Bring vaccination record to appointment)

# **Green Card Information**

## What is Needed?

- Form I485
- Form I693
- Appointment with Civil Surgeon (Schedule in advance of 1 year mark, as there may be a waiting list)

## ***Necessary documents when sending forms:***

- I94
- Evidence of residency in USA for 1 year
- 2 passport style photographs
- Copy of Government issued ID
- Travel document



# **Green Card Information**

Things to Know to complete and send application

- Only use Black ink to fill in I485 and I693 forms
- Do not send original copies of documents
- Mail (USPS) completed I485, I693, and all documents to USCS processing Center:
