

DOCUMENT EXAMPLES:

1. **US VISA**: SIV's have a temporary visa upon arrival at US airport. They receive the permanent Visa (green card) 2-3 months after arrival.
2. **I94**: Important document to have copies of until client receives their green card (after 1 year of arrival-Need to apply)
3. **Travel Letter**: Refugees, **except SIV's**, come in with travel letter and should have original. Needed for applications and important to keep.

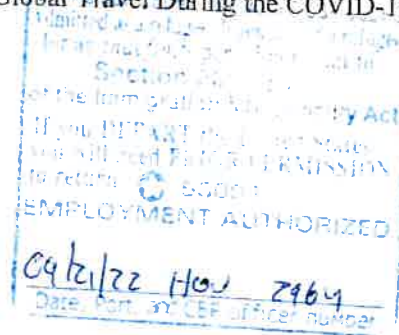
