

## Good Neighbor Team Engagement Ideas

This tool helps Good Neighbor Teams (GNTs) identify meaningful ways to engage with their matched program participants. It outlines nine focus areas, each paired with engagement ideas based on the participant's level of stability, using the framework of Relief, Rehabilitation, and Development. This structure is guided by the When Helping Hurts principles developed by The Chalmers Center.

- Relief Immediate responses to urgent needs
- Rehabilitation Efforts to restore stability and function
- **Development** Long-term strategies for growth and sustainability

Identifying which phase the program participant is in for each area is essential in providing the appropriate support. Tasks listed are just ideas and may not be appropriate for, or desired by a particular program participant. This resource can be used to help guide the development of a Good Neighbor Team Program Participant Plan.

Health & Mental Health	<ul> <li>Address urgent health needs</li> <li>Obtaining initial health screenings</li> <li>Secure primary care and dental healthcare providers</li> <li>Assist with medical needs and health education</li> <li>Apply for Medicare or other health insurance</li> <li>Secure needed medications</li> </ul>	<ul> <li>Teach how to access prescription and over-the-counter medications</li> <li>Explain appropriate use of 911, ER, urgent care, and doctors' appointments</li> <li>Promote greater self-sufficiency in healthcare navigation</li> <li>Assist with accessing mental health services</li> <li>Teach RMA/Medicaid transportation use</li> </ul>	<ul> <li>Promote preventative care and self-advocacy</li> <li>Introduce options for sport, exercise, and physical recreation</li> <li>Access to healthy foods</li> <li>Access lower cost healthcare options</li> <li>Help access safe, natural remedies from their culture that may be hard to find</li> </ul>
Finances	<ul> <li>Complete DHS (public aid)         Applications</li> <li>Cover initial expenses</li> <li>Provide grocery gift cards</li> <li>Connect to local resources (e.g., food pantries, discount stores)</li> </ul>	<ul> <li>Set up bank accounts</li> <li>Teach bill payment (rent, utilities)</li> <li>Explain account security (bank, credit, EBT)</li> <li>Encourage tax filing</li> <li>Introduce saving strategies</li> </ul>	<ul> <li>Coach family on budgeting, credit, and resource management</li> <li>Teach investing basics</li> <li>Share financial coaching/workshop opportunities</li> <li>Identify and plan towards long-term financial goals (home, car, education, starting a business, etc.)</li> <li>Teach emergency and retirement planning</li> </ul>
