Throughout the world, millions of children are displaced by conflict and violence, and we appreciate your care for their plight.

We are praying for this Administration that you would not grow weary in doing good and will work to ensure that every single child is safely returned home.

We continue to urge the Trump Administration to ensure that this remains a central issue and that all estimated 35,000 children are returned as a precondition to any peace talks. In ensuring all children are returned, it's essential that work identifying and tracing the current locations of these stolen children continues.

As a leader, a mother, and an advocate for the protection of children, you have the power to ensure no child is left behind. We urge you to use every resource at your disposal to continue your monumental work in ensuring Ukraine's children are returned home.

We are grateful for your partnership and continued efforts to secure safety for these children and for children around the world who are victims of conflicts outside of their control.
